With a referendum date set for June 2016, at the time of writing, some significant forces are building up in favour of a UK exit from the European Union. The possibility of a Brexit leads to a number of questions, such as:-

- 1) Will Italian resident British citizens be allowed to vote in the election?
- 2) As a long term resident of Italy will I be entitled to Scottish citizenship in the event of a Brexit and full independence for Scotland?
- 3) What are the timescales and costs of applying for Italian nationality?
- 4) What are the tax consequences of applying for Italian nationality?
- 5) Would UK join the European Economic Area? What would this mean?
- 6) What other things might impact my life in the event of a Brexit?
